

HIV/AIDS is the most important modifiable cause of premature death. Preventing HIV/AIDS is the single most effective thing that PLWHA can do to enhance the quality and length of their lives. The identification of High risk to low risk population and provision of preventive services among inmates is a viable framework on which to base interventions designed to promote HIV prevention in the jails of Pakistan & its practice by preventive care . Understanding the role of attitudes and perceived behavioural control is of central importance to ensure all potential primary care physicians can promote the chain of prevention expeditiously whenever the need arises.
